Title of report:	<b>Rural Mobility Pilots update and decision</b>
Purpose of report:	<b>Decision requested on the award of funding for Rural Mobility Pilots</b>

#### Recommendations:

The members of the Board are recommended to:

- I. Note progress on the Rural Mobility Pilot project.
- II. Delegate decision of outcome of call for pilots to a volunteer Board Member, or alternatively the STB Programme Team.

## 1. Background

- 1.1 The South West Rural Mobility Strategy was developed in partnership with Peninsula Transport in 2022. One recommendation from this strategy was the development of a series of rural mobility pilot projects to test novel approaches to improving sustainable access to services in rural areas.
- 1.2 The Board approved funding of £37,000 in FY 2023/24 and a further £50,000 in 2024/25 to deliver this project. This is matched by contributions from Peninsula Transport.

## 2. Current progress

- 2.1 The call for pilots went live on 25<sup>th</sup> October 2024, with more information found in the prospectus and technical annex published on the STB website. The deadline for applications is 8<sup>th</sup> December 2024. External organisations will have the opportunity to bid for up to £50,000 to develop proposal for a rural mobility pilot project, from idea to full business case/funding application. Western Gateway will then support those successful applicants to submit funding bids with the intention of securing full delivery funding.
- 2.2 In order to award the grants this financial year, there are strict deadlines to be met for the financial due diligence to be completed and approved by WEMCA Committee, as our accountable body. A decision on the winning application(s)

needs to be made by Wednesday 10<sup>th</sup> December, only allowing 48 hours to assess the submissions and make the recommendations to the grant assurance team. STB officers will conduct an initial review and make recommendations to the delegated Board Member or Programme Team by 5pm on Tuesday 9<sup>th</sup> December for final approval and sign off on the 10<sup>th</sup>.

### **3. Request for approval**

- 3.1 Western Gateway officers request a delegated Member from the Board to assess applications received through the Call for Pilots by Wednesday 10<sup>th</sup> December 2024 and award funding of up to £50,000 to successful bidders.

### **4. Next Steps**

- 4.1 To award the grants to winning organisations to begin the rural mobility projects in the South West this financial year. STB officers will provide an update on the progress of the pilots at a future Board meeting.

### **5. Equalities Implications**

- 5.1 No adverse impact on any protected groups is expected.

### **6. Legal Considerations**

- 6.1 Western Gateway will be awarding funding to external organisations, which may include charitable organisations, community groups and/or private enterprises as well as Local Authorities. We therefore have an obligation to exercise due diligence in the selection of a suitable recipient and to ensure good value for money is secured.
- 6.2 We will look to West of England Combined Authority, as our accountable body, to provide oversight on this matter, and we will comply with all necessary processes and requirements to ensure this is achieved.

### **7. Financial considerations**

- 7.1 Budget for this work element has already been approved as part of the 2024/25 business plan.
- 7.2 It is an ambition of this work that additional external funding will be secured for the delivery of pilot mobility projects in rural areas.

### **8. Conclusion**

## Appendix 1: Outline Prospectus Content

The prospectus sets out a vision to make our rural areas more 'liveable' and adopts the concept of 'liveable rural communities' as the central focus. Essentially this aims to enable residents and visitors in a rural area can access their daily needs locally, affordably and reliably, whilst striving to achieve Net Zero.

The document identifies six 'grand challenges' that are seen as the major barriers to achieving liveable rural communities. These challenges are shown below in Figure 1.

The expectation for the prospectus and associated pilot projects is that they should aim to address at least one of these challenges as part of their scope and solution.

A preliminary call for pilots was undertaken in early 2024 in order to understand the scale of interest in this type of programme and the likely types of solution to be proposed. In total, eight pilot proposals were submitted from various stakeholders across the South West. These initial applicants will be invited to submit to the funding process set out within the prospectus.

The prospectus process identified ten pilot concepts to provide applicants with practical examples of projects. These are detailed within the prospectus, and include projects related to tourism, accessibility, safety, decarbonisation and freight. The concepts vary significantly in their focus and their ambition. With the funding currently available, it is likely that only one or two of the ten concepts, with match funding and resources, will be practical to deliver.
